### Strategic Investments for Resilient Agrifood Systems: Driving SDG Progress through Partnerships

#### Abstract:

Building resilience in agriculture is non-negotiable: 2024 was the hottest year on record, with extreme heat threatening 1.2 billion livelihoods, while outdated systems impose \$12 trillion in hidden costs to society annually. Transformation at scale requires cross-sectoral action, encompassing secure water resources, affordable energy and rural infrastructure, grounded in a participatory approach. This would offer a tenfold socio-economic and environmental return, unlocking \$4.5 trillion in business opportunities per year. However, current investment models are highly fragmented, not grounded in the mandates and capabilities of each sector.

Through a multi-sectoral lens, we will explore how strategic agrifood investments can accelerate progress on the Sustainable Development Goals 6, 7, 9, 11 and 17, as well as showcase how multi-partner platforms can sequence and align financing to better leverage increasingly scarce resources. The event will demystify the roles of each sector - public, private, and multilateral actors - in financing agrifood systems through a coordinated and field-tested process. A follow-up partnership guide will be developed, synthesizing recommendations for integrated SDG action.

### **Objectives:**

1. Explore multistakeholder partnerships for integrating climate resilience, water/energy security, and inclusive infrastructure considerations into agrifood investment strategies
2. Examine the complementary roles of public, private, and multilateral partners in financing resilient agrifood systems, ensuring alignment with sector-specific capabilities
3. Lay the groundwork for a partnership guide to unpack coordinated investment mechanisms, enabling integrated and participatory SDG action
